<u>Updated Document: COVID-19 Response and Decon Protocol 5.6.20</u> (new for B-Division) COVID-19 Positive Screen:

- A positive screen is any patient with these symptoms or combination of symptoms:
 - Cough, shortness of breath or difficulty breathing
- Or at least **two** of these symptoms:
 - Fever, repeated shaking with chills, muscle pain, headache, sore throat, the new loss of taste or smell

Encounter vs. Exposure:

- Encounter: within 6' of a patient who screens positive for potential COVID-19
 - o Full PPE (N100/N95), gown, gloves, and goggles) without a breach
 - Option to document on a Minor Injury Form
 - DICO contact is <u>NOT</u> required



SAFETY MESSAGE

- Exposure: within 6' of a patient who screens positive for potential COVID-19
 - o Missing any PPE (N100/N95, gown, gloves, or goggles) or a PPE breach.
 - Any aerosolized procedures including suctioning, CPAP, nebulized mediations, bag-mask ventilation, advanced airway placement, chest compressions, as well as patients with significant coughing/sneezing.
 - o Extensive body contact with a patient.
 - When the scene stabilizes, contact DICO.
 - Complete Communicable Disease Exposure Report. Complete on scene (legible, include FS#), enter names of exposed crew members, take a photograph of form and email to DICO call taker who contacted you, send the form to hospital with the patient (if not possible, ensure form is delivered to the hospital ASAP).

Lessons Learned

- It is preferable to send the Communicable Disease Exposure Reports with the ambulance crew to the hospital. If you are unable to do this (i.e., moderate/acute status patient with short scene time), work through your chain of command to get the original form to the hospital and attached to the patient ASAP.
- By following the COVID-19 Response & Decon Protocol and assuming all patients, regardless of dispatch complaint, may have COVID-19, you will ensure best practices are followed and minimize exposure risks to you and your crew members.
- South bay districts (6, 29, 30 & 43) continue to see significant increases in COVID cases relative to the rest of San Diego County. Battalion 6's District makes up approximately 18 percent of all confirmed cases countywide <u>City of San Diego Dashboard</u>.
- Morning briefings are intended for all personnel. Important messaging may be lost when relaying pertinent information as well as stifle healthy discussion amongst the crew. Staying current on information provided will help ensure the safety of you and your crew. Don't allow the lack of communication to become another "lesson learned" for the fire service.
- Personal beliefs should NOT influence your decision when deciding which City or Department policy to follow. As a supervisor, your choices have a far-reaching impact on the health and safety of your crew and the public we serve.



SAFETY MESSAGE

- Continue to educate outside agencies/personnel on scene of any potential exposure risks due to the lack of personal protective equipment (i.e., Border Patrol, SDPD, MTS).
- Face shields or goggles continue to be the preferred level of eye protection.
- Depending on the status of a patient, your first three actions should include 1. Place a mask on the patient; 2. Take a temperature; and 3. Ask COVID related questioning.
 - o If needed, slow down the tempo of your call (i.e., back out and don the appropriate PPE).

Updated Document: COVID-19 Response and Decon Protocol 5.6.20 COVID-19 Positive Screen:

- A positive screen is any patient with these symptoms or combination of symptoms:
 - o Cough, shortness of breath or difficulty breathing
- Or at least **two** of these symptoms:
 - o Fever, repeated shaking with chills, muscle pain, headache, sore throat, the new loss of taste or smell

Encounter vs. Exposure:

- Encounter: within 6' of a patient who screens positive for potential COVID-19
 - Full PPE (N100/N95), gown, gloves, and goggles) without a breach
 - Option to document on a Minor Injury Form
 - DICO contact is **NOT** required



SAFETY MESSAGE

- Exposure: within 6' of a patient who screens positive for potential COVID-19
 - Missing any PPE (N100/N95, gown, gloves, or goggles) or a PPE breach.
 - Any aerosolized procedures including suctioning, CPAP, nebulized mediations, bag-mask ventilation, advanced airway placement, chest compressions, as well as patients with significant coughing/sneezing.
 - o Extensive body contact with a patient.
 - When the scene stabilizes, contact DICO.
 - Complete Communicable Disease Exposure Report. Complete on scene (legible, include FS#), enter names of exposed crew members, take a photograph of form and email to DICO call taker who contacted you, send the form to hospital with the patient (if not possible, ensure form is delivered to the hospital ASAP).

Lessons Learned

- If a company officer believes an exposure occurred on a patient who was NOT transported to a hospital (i.e., AMA, 11-44), a Communicable Disease Exposure Report can still be submitted to DICO. The County does not collect Communicable Disease Exposure Report forms for patients who are not transported to a hospital.
- Continue to educate outside agencies/personnel on scene of any potential exposure risks due to the lack of personal protective equipment.
- Recognizing that having bystanders on the scene will make it challenging for delays in starting patient care when donning PPE, consider rotating crew members out to don gowns when appropriate.
- Face shields or goggles continue to be the preferred level of eye protection.
- Depending on the status of a patient, your first three actions should include 1. Place a mask on the patient; 2. Take a temperature; and 3. Ask COVID related questioning.
 - o If needed, slow down the tempo of your call (i.e., back out and don the appropriate PPE).
